



## Election Candidates, AGM 2023

The Nomination Committee will present a final report at the Annual General Meeting on 12<sup>th</sup> December 2023, setting out that the candidates for election are as follows:

### Candidates for Election to the Board

<b>Michael Carrick</b>	An accountant by profession, Michael has recently retired from An Post, having joined in 1982 as a Postperson and subsequently served in a variety of roles including Compliance Manager, Internal Audit Manager and Retail Finance Manager. Michael served on the Board of An Post Employees' Credit Union for a number of years and was co-opted to the Board of Public Service Credit Union in May 2023 following the merger of both credit unions.
<b>Brian Martin</b>	Brian is educated to degree level and has worked for many years at Dublin City Council and was formerly a Postmaster in his hometown in Co. Leitrim. Brian served on the Board Oversight Committee of An Post Employees' Credit Union for five years and was co-opted to the Board Oversight Committee of Public Service Credit Union in June 2023 following the merger of both credit unions.
<b>Mary McKeon</b>	A graduate at Master's level (MScEcon) and with various professional qualifications, Mary enjoyed a senior career in the civil service, latterly in the Department of Finance. Now retired, Mary is the current Vice Chairperson of PSCU having served on the Board since AGM 2020 and is also involved at leadership level with several national bodies in the charity and public service sectors.
<b>Ciaran Rohan</b>	Ciaran is educated to Master's level with his most recent civil service posting at the Department of Education. He is General Secretary of the Association of Higher Civil and Public Servants (AHCPS) and has held various associated roles at the Irish Congress of Trade Unions. Ciaran has served on the Board of PSCU since the 2020 AGM.

### Candidates for Election to the Board Oversight Committee

<b>Brendan Doherty</b>	An accountant by profession, Brendan has worked in various government departments and is currently working at the Department of Health. Brendan also has extensive private sector and overseas experience having lived in the UK, Canada and the US, where he worked in the US credit union sector for a period. He has served on the Board of PSCU, including in the role of Treasurer, for two extended periods. Following the merger with An Post Employees' Credit Union, Brendan stood down from the Board of PSCU and was co-opted to the Board Oversight Committee in May 2023 where he is the current Chairperson.
